- **10.1 Maintenance -Mr. Zamora-** been keeping up with our regular duties and we did install a new slide in our playground that needed replace, we been working on the soccer fields and painting the lobby staying out of the heat **Mr. Jimenez-** we need to look into how we are going to prevent the balls going into the neighbors' houses
- 10.2 Recreation- Mrs. Gonzalez- last weekend we had our Lamont tournament for Jr. Giants thank you to our District Manager for coming out and helping with the food and thank to Mr. Pimentel for taking a team and Mr. Zamora for taking care of the field and this Saturday we will be having the Arvin tournament and we will be done with Jr. Giants I will just to submit inventory, now we are going to get ready for soccer we have a total of 96 kids registered for our soccer league, me and Mr. Pimentel are getting together to talk about the tournament putting it together, one thing that I wanted to add is that I'm going to need help to get the field ready for Saturday we were thinking if you guys get approve that during the season maybe he can get the fields ready and get the field free on Sundays in return (service for service) Mrs. Cervantes- is that legal Mrs. Gonzalez- little league in Arvin does that I wanted to see if we can do something like that Mrs. Miller- if you guys have the

power to renting the field I believe you have the power to do something like that whether or not you want to charge somebody or not Mr. Perez- if he expecting to reserve the field I would like to have those days and times on file he would have to reserve those days with us, he should definitely have a reservation Mr. Miller- in addition if anyone wanted to reserve the field at that time you would know what time he would be using the field so it could be available for someone else to reserve it and if his going to be doing this for you guys each Saturday that its stated on there as well otherwise he can do it the first Saturday and then not do it Mr. Perez- I don't want him to blow you off, I know some checks were in the mail Mrs. Cervantes- we deposited two check from the person that was here in our last meeting but were still waiting for some, we also got another check from Grimmway they had already donated 550 dollars when we sent out the first letter and then we received another 1,000 that a coach helped us get Mr. Jimenez- the kids that have signed up paid the 60 dollars Mrs. Gonzalez- yes the 96 kids that are registered have already paid there some that haven't paid but I'm not counting those as the part of the 96 Mrs. Villanueva- the person that you are talking about his just going to help but you're going to run the league you're going to be 100 percent in charge of the league or is that person going to be able to do part of your work Mrs. Gonzalez- I'm the one that is going to be in charge of the league Mrs. Cervantes- his only going to be in charge of measuring and doing the lines

District Manager- Mrs. Cervantes- we had our open bids on August 15th we had 10.3 four for fencing, one for the resurfacing and one for the lighting I'm giving them to Shannon so they can take them and go over them, then they will bring back something to the board, in my opinion I think we might have to go out to bid again for the resurfacing and the lighting the prices were really high Mrs. Cervantes- for the resurfacing \$144,351 for the lighting it was \$156, 500 and for the fencing we have four different ones \$43,753, \$33,552, \$40,742 and \$59,646 with the budget that we have we would just be able to do two of these items and still come out of pocket Mr. Zamora- a couple of our contractors called me the next day and were confused about the dates on the bids and they gave me some pricing is \$70,000 and whoever bid \$140,000 that is just way to high, what I can do if we put it out for bib again ill reach out to them and make sure they go out to bid Mrs. Cervantes- I do have a meeting scheduled with Melinda from the state parks is going to be coming and I will be going to be going through this issues with her regarding the grants and I'll be going through this issues with her
