Mr. Hodges- what would be your purpose what would be your goal Mr. Perez- with this we would essentially have more resources to provide more recreational activities for the communities within our boundaries Mr. Hodges- who requested these meetings is this to say Bear Mountain would like to request these meetings with Tejon Ranch Mr. Perez- yes Mr. Hodges- so you have not been approached by Tejon Ranch Mr. Perez- no this was just an idea the district manager and myself have talked about it in the past Mr. Hodges- what would be your purpose what would be your goals out of these types of meetings Mr. Perez- to increase our property tax revenue Mr. Hodgeshow Mr. Perez- by encompass the area that is not in our district Mr. Hodges- you already go out close to the outlets Mr. Perez- we would also like to encompass the outlets and the area were they are planning to build more homes Mr. Hodges- my concern with that is that, you will increase your revenue but to properly obtain that you would have to provide recreation down there and I don't know if you have the resources to put enough time into having a separate park essentially 45 minutes away from here, if you want to take that ramp that's awesome but you would have to be able to provide services number one you would have to figure out how much revenue is this going to bring is that enough to support essentially a separate operation down in that area there's a lot of questions that you need to right down before you even go into these meeting and a lot of areas that you need to have in your mind these are the discussion points before we even go ask for any of it, how much is it suppose to grow how many people will you be serving because that community can become as big as Lamont and Arvin put together if it grows to that size the tax revenue can double of what we have now but you would have to put up some new buildings, buy new equipment and you would have to have staff out there it's a lot to go into to it, I'm not saying don't do it I'm just saying if I was you I would form a Ad Hock committee to discuss what steps can be taken before we sit down and meet with these people Mr. Jimenez- I think we should get a little bit more information before we start the processes Mr. Perez- I was told that they are going to built parks already and we would not have to do that but like Nathan said if we have a community out there we need to provide activities for them Mr. Hodges- well here is the problem if you don't there going to go to LAFCO and they are going to pull out that property out and they are going to service it themselves there going to form there own special district my recommendation is that you create a Ad Hock committee to look into this and what needs to happen in order to move forward with a project like that and that committee can bring back to the board these are our discussion we came out with these nine steps that need to take place before something like this can happen and in order to fulfill these nine steps we need to get answers to these questions so were are going to go to these meeting and meet with them and were going to try to figure out whether we can meet all of these issues and if we cant we can

bring it back to the board and say this is what we found out lets vote one way or another but this exploratory committee I think is the only way that you guys can really proceed with this and do it effectively with the knowledge in what are we really getting into **Mr. Pere-** were there be a recommendation from our legal counsel **Mr. Hodges-** just to add a Ad Hock committee
