General Manager Report:

- 8.1 Maintenance -Mr. Zamora- the multipurpose court is almost completed and we been having leaks at the Arvin Swimming pools under the deck so I had a leak detector company come out, next week we are going to cut it open to repair the leak, we been having a leak too at the Bear Mountain Park and that is all for that and as all you guys know this will be my last board meeting as maintenance supervisor I would like to thank the board and staff for all the support I feel that its my time to do different things and move on and let someone else take over I'll be around I know that there going to be stomped on some things Mr. Rodriguez- good to have worked with you hate to see you leave but you got other things that you'll like to do wish you all the luck Mr. Alonso- thankyou for all the work that you've done even though I just been in the board for a few years but in that time you always had a good work ethic thank you very much and good luck Mrs. Villanueva- thank you very much for everything I know is hard for us cause you worked and help us but maybe you have special dreams and good luck Mr. Perez-thank you Anthony without hesitation that without you we wouldn't have water in one of our parks you have saved us thousands of dollars on different projects you have helped us keep our pools open when we have had leaks, remodeling our offices, the roof and the graffiti and I really appreciate all the support we as the board have felt from you as a staffer and as a lead for our maintenance division, thank you for your dedication
- **8.2** Recreation- Mrs. Gonzalez- thank you Anthony for always helping, Saturday August the 12th we had around 500 people we had people at Alicante School and here at Bear Mountain Park and David Couch donated 1,000 dollars for our barbecue we had hamburgers and hotdogs and thank you Mr. Perez for helping with the barbecue I

want to thank Lucia Alcala and Roselia for helping out and Juan Villalpando for setting up the fields, we had around 24 teams with the kids, parents and coaches it added up to around 500 attendees, and we are getting ready for soccer so far we have around 115 kids registered I'm hopping we are going to get more today I took some flyers to Arvin Schools the girls in the office helped me with the flyers Mr. Perezwhat is our target goal Mrs. Gonzalez- we need around 240 kids Mrs. Villanueva- I would like to have attended but I wasn't aware that it was going on I wasn't notified and Mr. Rodriguez- what do you mean by plan B can you explain Mrs. Villanuevato have people designated to a section for example who's going to barbecue, how many coolers we have to keep the food refrigerated or have funds to rent more grills I want to ask if in the future we can have a plan B to be more organized Mrs. Gonzalez- I had everything organized but the person that helps me with the barbecue that was one of our coaches passed away that's something that I control we have a grill at the last minute I sent messages to all the coaches that we needed grills but they already have a lot on there plate with all the kids they are volunteers we don't pay them the parents sometimes don't answer there text and regarding the meat I had coolers full with ice we made sure that everything was in the fridge and one of our worker Rosie has her food safety certificate so she knows how to manage certain meats, I feel that our food was good taken care off, regarding the grills is something that I couldn't control, but its true what you said to always have a plan B and right now I want to take a moment to say thank you to Denise Sosa for always helping and volunteering her time for many years Mrs. Villanueva- can I know when you found out that the coach passed away Mrs. Gonzalez- a week before Mrs. Villanueva- in a week you could of make a B plan Mrs. Gonzalez- our parents didn't answer Mrs. Villanueva- but you have the support of our District Manager if you would have notified her she could have gotten a grill Mrs. Cervantes- the truth we didn't think of doing that, everything happened so quickly we always had the help from the coach that passed away and like she said she did send text to coaches and parents and didn't get response, until the day of we had a parent bring a grill out Mrs. Gonzalez- I also want you to understand I run two leagues at the same time our baseball and soccer the food for the tournament I had to go buy myself I didn't have help I used my own vehicle Mrs. Rodriguez- how did Director Villanueva know all this if she didn't attend Mrs. Villanueva- I had a lot of people call my house and complain Mr. **Rodriguez-** I think it would have been better to make the comments to our recreation coordinator that she had complains I think it would have made it more clear I think that would have been the proper way, its kind of confusing when someone brings that to the board when the first thing you hear is that you didn't attend the tournament and that all these things went wrong Mr. Perez- one thing that I would like is that more people get there food handler certificates.
