4. APPROVE AGENDA AS FORM

Mr. Hodges- we were contacted by an engineer that is working for a developer they are putting 184 new homes in the corner of Panama and Weedpatch Hwy 50 acre development and they are required to pay a fee to the district, there's basically two options that a new developer has they can either dedicate land or pay a fee if the district would have a park in that location they would have to dedicate the land but since the district does not have park there they have to pay a fee and they would have to negotiate with the District for that fee
