8. DEPARTMENTS REPORTS: General Manager Report:

8.1 Maintenance -Mr. Zamora- or mower is not working as of now that's why the grass is a little high I order the part to repair it and we been having kids break in the pools almost every day I kicked like ten of them out the other day and told them that I was going to call the sheriffs and they said its okay the passed already a few times and didn't do anything and the fence is being damaged if I would call the fence company every time it would be like five hundred dollars Mrs. Rodriguez- is there any way you can contact the sheriffs department Mrs. Cervantes- we have talked to them and they don't do anything Mr. Hodges- get a form from the sheriffs department that shows the times that they have traced passed Mr. Perez- maybe we can make an ordinance that such trespassing would result in a fine Mr. Hodges- sure we can once we have a couple of kids that damage the fence pay restitution to the district they will

- think twice before doing any damages I think doing it in Arvin with the police department will be easier since they are always there **Mr. Zamora-** we already started work on the tennis court and put up a fence and on June 2nd they will start with the demo
- 8.2 Recreation- Mrs. Gonzalez- I'm getting ready for Jr. Giants; Arvin does not look good we have 21 players for majors 24 for minors and 18 players for t-ball I don't think we are going to have Jr. Giants in Arvin, we have two Ameri Corp we have one for Arvin and one for Lamont I have them both work together posting flyers in Arvin, Arvin just started a new baseball league and it is competitive what I'm thinking these kids are getting registered in that league, we can't make competitive at all we will lose the program so what I'm planning to do is to invite them to come and play in Lamont, I also provided you with a slide show that we are going to be having for the soccer league to provide information on whet the fees are going to be use for and hopefully we will get a group of parents that will come and help and get more involved, and for Jr. Giants we are going to have our first pitch meeting here at the David Head Center on June 6th and I was also having one in Arvin but with the numbers being so low I might not have it Mr. Alonso- here were it says parents and guardians where it says three warnings and if there are parents and guardians that don't obey and leave the game what is the plan for that Mrs. Gonzalez- we have the parents sign a waiver with these rules on them and we have been having parents that are respectful and that's why I would like to have that meeting before the league starts, I had an incident were a parent wouldn't stop screaming and the coaches stopped the game till the parent stopped and that took care of the problem so working together helps and its been a onetime thing Mr. Alonso – has there been any issues with a coach and volunteer acting bad is there any steps that would happen in that regard Mrs. Gonzalez- what I do is that I have a meeting ahead of time and a team parent meeting and we had a coach one time that said I don't agree with this and decided not to coach

8.3 District Manager- Mrs. Cervantes-

a) Written Communications- Mrs. Cervantes- we did get a response back from Scott from the Lamont Public Utility he said he presented Bear Mtn's revised/modified counter-offer lease agreement to his board his board stated given the significant changes requested including a 50% credit, which they chose to reject, coupled with your request to add a special classification and the rates to charge (which the prop 218 process and which my Board stated they will not do), and retaining ownership of the shade structures should the lease expire or terminate (which they stated LPUD cannot and would not simply deed over \$2 million worth of LPUD infrastructure) my Board has directed me to reject Bear Mtn's counter-offer/revisions in total. Thus, I regret to inform you that my Board has chosen to go in a different direction and look for more affordable and realistic options for solar project Mr. Hodges- I want the board to know that we are not violating Prop 218 Mr. Perez- in this situation were he providing us in writing and this is now a public document right because its been entered into the minutes under written communication there's information in there that is not accurate he says that it violates prop 218 and it doesn't right legal counsel Mr. Hodges- no we do not violate Prop 218 Mr. Perez- I just came back from the CRPD

conference were we talked to leadership through out the state for our organization for the association and they all agreed and they gave examples of themselves that they have great relationships with there community water district and they simply do not understand why we don't have a special classification we are all here for the publics benefits at least I that written letter it gives us a hint that we are not getting factual information from them we just heard it here from our attorney that the things that we asked for do not violate Prop 218 process Mr. Hodges- it would violated if they just created a class out of thin air but the way the contract was drafted the way that the proposal was drafted they have time to create this class and they will continue to charge this district the same rate that they are currently charging once that new class is created then it could retroactively apply it to the district so if they have an issue with that we can talk about the procedure but creating a class there is nothing wrong with that, it would be a violation if they just said yes we are going to create one and we are not going to go through the proper procedure that's not the way the contract is drafted Mr. Rodriguez- is there anyway that our attorney look into this see if we can get these benefits Mr. Hodges- it would be up to the water board to do this they are the ones that would have to create a class Mr. Rodriguez- so in another words if the LP UD wanted to give the district a better rate in water they could Mr. Perez- yes they could set us up at a special rate and his not going to give his board the type of report that our district council gave us his going to tell them that its illegal and that he recommends no Mr. Rodriguez- well that's not up to him is up to the board, someone needs to go up to the water district here in Lamont make a presentation
