I also want to say thank you to Mr. Rodriguez and Mr. Horton for all your support for your guidance and your vision and helping us grow and I want to welcome the new board members Mr. Perez- one thing that I would like to add to the district managers report is that yesterday the office manager and I were on a call regarding AB617 is a 40,000 million grant that Arvin and Lamont are looking to get I wanted to make a note of that, that our office manager and I were on that call the call lasted around a hour there's been some delay in granting us those funds December 10th was when we were going to get a yes or no and now its going to be February will be representing Bear Mountain as far as that goes Mr. Jimenez- do we have a update on the Mini Pitch Mrs. Cervantes- we received a letter that the doner was considering to go somewhere else were waiting on them to let us know if they don't let us know by January, will submit the application to PER Capita on February or March of 2021 Mr. Jimenez- when is the due date for that application Mrs. Cervantes- December 2021 Mr. Perez- I wanted to add regarding the COVID funding the CARES act funds 88 districts were eligible in Kern County for this and were not only the first on the call were the first to be recorded and we were also the first to have the agreement, when it comes to that a kudos from the district manager the board our district counsel for calling a special meeting and really getting that done fast we were the first were talking about getting reimbursed 32,000 dollars.
