Mr. Hodges- this is an issue that arose based on the potential donation of walking paths to the district I didn't have a definite answer for you at the time I took a class and did research on this issue is still in a gray area because were are dealing with district improvements basically improvements to public property and that would fall under prevailing wages at any time that there is an improvement to public lands it's a public improvement and it falls under prevailing wages the caveat out there the statue essentially states when public funds or the equivalate of public funds are used for this improvement for this capital improvement then prevailing wages applies so we have to different elements that we are dealing with public funds and public lands for capital improvements because we don't have any public funds that are being used to improve the actual land is a gray are so from the research I've done my conclusion is that we can move forward with this projects without prevailing wages as long as the agreements that we have if the other side informs them that this might fall under capital improvement and that prevailing wages might apply and there for we are giving you notice of it and telling you to go do your own research and were are telling you to

indemnify us if anything happens out of this project and I believe as long as we put those two provisions inside of any agreement or any mem of understanding and we put them on notice that this might apply we don't believe it does but it may you're doing this at your own risk we are not putting any money into this we are not doing any work into this
